Dear Sir,

I have the honor to inform you that the Government of Japan has decided to offer some scholarships to teachers for the programme of Teacher Training Students under the Japanese Government (Monbukagakusho:MEXT) Scholarship for 2016 for professional improvement to conduct research on school education at a Japanese university for the period of one year and a half beginning from October 2016.

The applicants must be a graduate of a university or a teacher-training school and have worked as a teacher of an elementary or secondary educational school or a teacher training institution in Thailand for at least five (5) years in total as of April 1, 2016 (In-Service university faculty members are not eligible). In addition, it would be preferable if Japanese language teachers at a secondary school are included as applicants for this programme.

In this connection, I would be much obliged if the Ministry of Education would kindly recommend a number of preliminary applicants together with the preliminary application forms and necessary documents to the Japan Information Service, Embassy of Japan not later than February 8, 2016.

The Embassy will screen the candidates by holding a written examination (English and Japanese language subjects), and an interview for applicants who passed the written examination.

The written examination will be held on Saturday, February 20, 2016 from 09:00 to 12:00 hours at Japan Foundation, 10th Fl. Serm-Mit Tower, 159 Sukhumvit 21 Rd., Bangkok. The interview for those who passed the written examination will take place on Friday, March 4, 2016 from 13:30 to 17:00 hours at the Embassy of Japan, 177 Witthayu Road, Bangkok. In this regard, it would be highly appreciated if the Ministry would be kind enough to recommend two (2) appropriate officials to serve as the selection committee and inform the Embassy the name and rank of the said officials at an early date.

Attached herewith are details of the scholarship, preliminary application forms, and tentative schedule for your reference and consideration.

JAPANESE GOVERNMENT (MONBUKAGAKUSHO: MEXT) SCHOLARSHIP FOR 2016 (THAILAND)

— TEACHER TRAINING STUDENTS —

The MEXT (Ministry of Education, Culture, Sports, Science, and Technology) offers scholarships to foreign students who wish to conduct research on school education at Japanese universities under the Japanese Government (MEXT) Scholarship Program for 2016 as follows:

1. QUALIFICATIONS

The Ministry of Education, Culture, Sports, Science and Technology (MEXT) is now accepting applications from overseas students for study in Japan. Our aim is to foster human resources who will become bridges of friendship between your country and Japan through study in Japan and who will contribute to the development of both countries and the wider world.

- (1) Nationality : Thai.
An applicant who has Japanese nationality at the time of application is not eligible. However, persons with dual nationality who hold Japanese nationality and whose place of residence at the time of application is outside of Japan are eligible to apply as long as they choose the nationality of the foreign country and give up their Japanese nationality by the date of their arrival in Japan. Selection is conducted at facilities such as the Japanese Embassy/Consulate General (hereinafter “Japanese legation”) located in the country of the applicant’s nationality.
- (2) Age : Not more than 35 years old (must be born on or after April 2, 1981.)
- (3) Academic Background : In principle, applicants must be graduates of universities or teacher training schools and have worked as teachers at primary or secondary educational institutions or teacher training schools in their home countries for five years in total, as of April 1, 2016. In-service university faculty members are not eligible.
- (4) Japanese Language Ability : Applicants must be willing to learn Japanese. Applicants must be interested in Japan, and be willing to deepen the understanding of Japan after arriving in Japan. Applicants must also have the ability to do research in Japanese and adapt to living in Japan.
- (5) Health : Applicants must be free from any mental or physical disability that would be an impediment to the pursuit of study in Japanese University.
- (6) Arrival in Japan : Applicants must be able to arrive in Japan within two weeks from the starting day of the study course set by the university in Japan (usually October) and the period set by the admitting university. (If the applicant arrives in Japan before the designated period for personal reasons, travel expenses to Japan will not be paid. Excluding cases of unavoidable circumstances, if the applicant cannot arrive in Japan during the designated period, the applicant must resign.)
- (7) Visa acquisition : Applicants must acquire College Student (ryugaku) visas before entering Japan. They then enter Japan with the “College Student” (ryugaku) residence status. Please also note that those who change their visa status to one other than College Student after arrival in Japan will lose their qualification to be Japanese Government Scholarship recipients from the date when their visa status changes.
- (8) Others: Applicants must return to their home country and resume their work immediately after the end of the scholarship period. Applicants shall utilize in their teaching careers the results of their research on school education in Japan. Should the applicant not return to the home country and resume work after the end of the scholarship period, the applicant must return the entire amount of the scholarship starting from the first payment.
In addition, while the applicant is studying in Japan, he/she shall contribute to mutual understanding between Japan and the home country by participating in activities at schools and in communities with the aim of contributing to the internationalization of Japan. The applicant shall make efforts to promote relations between the home country and Japan by maintaining close relations with the university attended after graduation, cooperating with the conducting of surveys and questionnaires after returning to the home country, and cooperating with all relevant projects and events conducted by Japanese diplomatic missions in the applicant’s home country.
- (9) Any applicant who meets any or all of the following conditions is not eligible. If identified after the start of the scholarship period the applicant will be required to withdraw from the scholarship.
 1. Those who are military personnel or military civilian employees at the time of their arrival in Japan.
 2. Those who have received a Japanese Government Scholarship (Monbukagakusho scholarship) in the past.
 3. Those who are currently enrolled at a Japanese university with a *College Student (ryugaku)* residence status; those enrolled, or

scheduled to be enrolled, at a Japanese university as a privately financed international student during the period when the scholarship application was filed in the home country until prior to the start of the provision of the scholarship. However, even if the applicant is currently a privately financed international student studying in Japan, this restriction does not apply to an applicant who will certainly finish the current course before the start of the designated course at the Japanese university and will return to the home country.

4. If an applicant is a grantee of a scholarship from any organization (including any governmental organization of his/her own country) other than the Japanese government (MEXT) (Prospective beneficiaries are included).
 5. Recipients who make a double application for this scholarship to other universities, other embassy recommendations, and the Student Exchange Support Program provided by Japan Student Services Organization (JASSO).
 6. Holders of dual nationality at the time of application who cannot verify that they will give up Japanese nationality by the time of the arrival in Japan.
- (10) Study courses implemented: Study/training is implemented only for university/training courses listed in the booklet "Course Guidebook for Teacher Training Students," distributed at the Embassy of Japanese. (The Course Guidebook will also be available on the MEXT website: http://www.mext.go.jp/a_menu/koutou/ryugaku/boshu/1354263.htm)

2. TERM OF SCHOLARSHIP

The term is the period necessary to complete each university's training course and should be between October 2016 (or the starting month of the study course) and March 2018. (Extension of the term is not allowed.)

3. SCHOLARSHIP BENEFITS

- (1) Allowance : 143,000 yen per month. (In case that the recipient research in a designated region, 2,000 or 3,000 yen per month will be added. The monetary amount each year may be subject to change due to budgetary reasons.) The scholarship is cancelled in principle if the recipient is absent from the university for an extended period. The scholarship will be also cancelled in principle in the following situations. If the recipient has been receiving the scholarship despite his/her falling under any of the following situations, the recipient will be ordered to return the amount of scholarship that he/she received during the period wherein he/she was involved with any of the following situations.

1. The recipient is judged to have made a false statement on his/her application.
2. The recipient has violated any article of his/her pledge to the Minister of Education, Culture, Sports, Science and Technology.
3. The recipient violates any Japanese laws and is sentenced to imprisonment with or without work for life or for a period of exceeding 1 year. However, this shall not apply to those who were found guilty with suspension of execution of sentences;
4. The recipient has been subjected to disciplinary action like expulsion or removed from registration by the university or institution where preparatory Japanese-language lessons are undertaken.
5. It has been determined that it will be impossible for the recipient to complete the study course within the standard time period because of poor academic grades or suspension from the university.
6. The recipient's status has been changed into one other than "College Student as defined in the Appended Table I-4 of the Immigration Act."
7. The recipient has received a scholarship from another institution (excluding those specified as being for research expenditures).

(2) Transportation

1. Transportation to Japan : The recipient will be supplied, according to his/her itinerary and route as designated by MEXT, with an economy-class airplane ticket from the international airport nearest to his/her home country residence * to the New Tokyo International Airport or any other international airport that the appointed university usually uses. Expenses such as inland transportation from his/her home address to the international airport, airport tax, airport usage fees, special taxes on travel, or inland transportation within Japan will NOT be supplied and should be borne by the student. (*The address in the country of the recipient's nationality stated in the application form is in principle regarded as the recipient's "home country residence.")
2. Transportation from Japan : A recipient who returns to his/her home country within the fixed period after the expiration of his/her scholarship will be supplied, upon application, with an economy-class airplane ticket for the

travel from the New Tokyo International Airport (or any other international airport that the appointed university uses as a normal route) to the international airport nearest to his/her home address*.

(Note 1) Any aviation and accident insurance to and from Japan shall be borne by the recipient.

(Note 2) Should the recipient not return to his/her home country soon after the end of the scholarship period to resume his/her duties, the transportation fee for the return to the home country will not be provided.

③ Tuition and Other Fees : Fees for the entrance examination, matriculation and tuition at universities will be paid by the Japanese Government.

4. DOCUMENTS TO BE SUBMITTED

Applicants must submit the following documents together to Bureau of International Cooperation, Office of the Permanent Secretary, Ministry of Education in Thailand by the required date. The submitted documents will not be returned.

*(Note 1) These documents must be written in Japanese or English, or translations in either of these languages should be attached.

*(Note 2) Regarding the diploma mentioned in (4,5), a photocopy thereof may be an acceptable substitute. However, this should be attested by the school authority concerned.

*(Note 3) No application will be considered unless the aforementioned application and all other documents are fully and correctly completed.

5. SELECTION

(1) The Embassy of Japan will carry out the primary selection from among applicants by means of a review of the submitted documents, a written examination, and an interview.

The written examinations will be English and Japanese Language. Please note that all applicants must sit for the Japanese Language test. Apart from Japanese language teacher, the Japanese Language score will be used for reference only.

(2) Results of the primary selection will be notified on the date separately designated by the Embassy of Japan.

(3) Applicants who pass the primary selection will be recommended by the Embassy of Japan to MEXT.

(4) MEXT will conduct a secondary (final) selection for the applicants recommended by the Embassy of Japan and decide the scholarship recipients.

(Note) In order to judge the level of language education needed for successful candidates after their arrival in Japan, written examinations in Japanese and English will be given for reference purposes at the time of the primary selection.

6. PLACEMENT IN AND SPECIALIZED TRAINING AT UNIVERSITIES

(1) The study/training is implemented only in the university/study courses listed in the booklet Course Guide for Teacher Training Students. The Course Guidebook will also be available on the MEXT website:

http://www.mext.go.jp/a_menu/koutou/ryugaku/boshu/1354263.htm

(2) MEXT, in consultation with the university concerned, will decide on the university in which each recipient shall be enrolled by taking into consideration his/her Japanese Language ability and the specialized courses he/she wishes to be enrolled in. Objections regarding university placement will not be accepted.

(3) The training at universities will be conducted in Japanese, in principle.

(4) The recipients whose Japanese language ability is insufficient will undergo Japanese-language education in a Japanese language study course at the appointed university or at a university designated by MEXT. Japanese -language education is generally provided for six months at the beginning of the program, but some of the accepting universities may conduct Japanese language education parallel

to the training.

(5) The training mainly consists of educational administration (such as educational administration and finance, school management), educational methods (examples: classroom teaching, learning system theory, curriculum, and educational assessment), specialized subject research (examples: mathematics, physics, chemistry, and gymnastics), and observational tours and practice (examples: class observation, participation in special educational activities, and tours of educational research facilities). Guidance plans will be organized flexibly according to the research themes the students wish to study.

(6) A recipient who has completed a specified course at the university concerned will be given a certificate.

However, the purpose of this scholarship program is not to obtain a diploma. Therefore, a recipient cannot be enrolled in an undergraduate course at a university or a master's or doctorate course at a graduate school as a Japanese-government-sponsored international student during the term of or right after the completion of this program. (This same restriction applies to privately financed overseas students enrolled in an undergraduate course at a university or a master's degree or doctoral course at a graduate school. If the recipient should be enrolled in such a course, the recipient will be required to pay back the entire amount of the scholarship money retroactive to the start of the scholarship payment.)

7. NOTES

(1) Each recipient is advised to learn the Japanese language and to acquire some information on Japanese weather, climate, customs, university education and conditions in Japan, as well as about the difference between the Japanese legal system and that of his/her home country before departing for Japan.

(2) As the first installment of the scholarship payment cannot be provided immediately upon the recipient's arrival, the recipient should bring approximately US \$2,000 or the equivalent to cover immediate needs upon arrival in Japan.

(3) Accommodations:

1. Residence halls for international students provided by the universities:

Some universities have residence halls for international students. The recipients enrolled at national universities where such facilities are available may reside, if they so desire, at these residence halls under certain conditions. However, because of the limited number of rooms, some of these facilities may not be able to accommodate all the students who wish to live in them.

2. Private boarding houses or apartments:

Those who are not able to find accommodation in the aforementioned facilities may live in regular dormitories of the university or in a private boarding house/apartment introduced by the university.

It is very difficult for recipients with dependents to find appropriate housing in Japan. The recipient is requested to arrive in Japan alone first to secure housing before having his/her spouse and/or family come over to Japan.

(4) In addition to the information determined in this guideline, matters which are necessary to implement the Japanese Government Scholarship are determined by the Japanese Government.

(5) More detailed information on this scholarship program is available at the Embassy of Japan.

(6) Information regarding the recipient (name, gender, birthdate, nationality, accepting university, graduate school/undergraduate school, specialty, period of enrollment, career path after completion of course, contact information [address, telephone number, e-mail address]) may be shared with relevant government organizations for the purpose of the use of the information in overseas student exchange programs (support during period of study, follow-up, improvement of the overseas student system) implemented by the Japanese Government.

Information regarding the recipient other than date of birth and contact information may be opened to the public after study in Japan in order to introduce the activities of returning recipients around the world in materials produced by the Japanese Government as publicity for promoting the acceptance of overseas students in Japan.

These matters are included in the Pledge stipulating rules and regulations which MEXT Scholarship recipients must comply with and submit when they have been granted the Scholarship. Excluding exceptional circumstances, only those concurring with these conditions will be accepted as MEXT Scholarship recipients, in principle, and will be granted the Scholarship.
